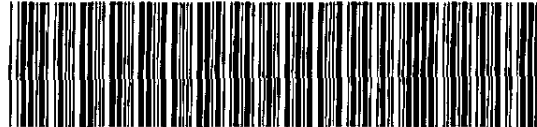

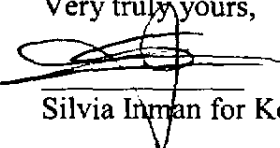

FIRST: Article I is hereby deleted in its entirety and replaced with the following:

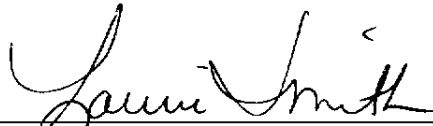
ARTICLE I: NAME
