

On September 6th I was notified that the annual reports submitted for Torgan Lake Enterprises (# P00000109456) and Second Life Enterprises (# P00000109461) we not being processed because they lacked the late fee assessment of \$400 each. The annual fee of \$150 each was, however, accepted. I am appealing the assessment of these late fees because we did not receive the annual notification from the Dept. of State prior to the May 1st deadline.

My wife, Patricia Franzen, contacted the Division of Corporations on August 22nd to inquire about the late charge because, when we had not received any renewal notification from the State, we had checked the Division web site and the annual report documents indicated the filing fee was \$150.00 which was due by September 7, 2005. This was done prior to the May 1st deadline. It was our assumption that the Division had instituted a staggered filing system and that, because our corporations began with the letters "S" and "T" that their filing date had been moved back to September. A copy of the document printed from the web site earlier in the year is attached.

A review of the records will show that we have filed timely and accurate annual reports since the inception of our corporations. This was our intent in this instance also, given that we filed on August 2nd for what we believed was a September 7th deadline. Therefore, we respectfully request the Division consider our circumstance and intent, and waive the \$400.00 late filing fee and dissolution for both Second Life Enterprises and Torgan Lake Enterprises.
