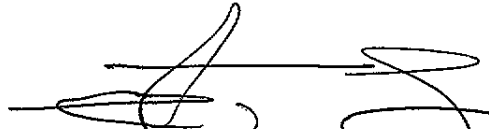

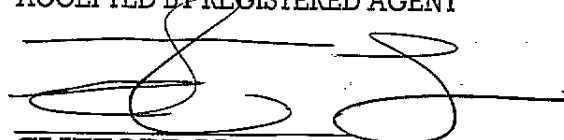
The undersigned, in order to form a business corporation under the laws of the State of Florida, as contained in the "Florida General Corporation Act", as amended, hereby certifies as follows:

1. The name of the corporation is **Zeny Floors, Inc.**
2. The duration of the corporation shall be perpetual.
3. The general purpose or purposes for which the corporation is incorporated are to represent manufacturers, distributors, importers and others in connection with the sale of flooring and related materials to consumers, contractors, intermediaries and other, and further to provide any and all other related or ancillary services as allowed under Florida law.
