#### ARTICLES OF INCORPORATION

OF

LESPY. INC.

The undersigned in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the Statutes of the State of Florida. do hereby subscribe to these Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is:

LESPY. INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- a)To construct, build, add, remodel, beautify, plaster, etc. buildings, residences, kitchens, fences and alikes.
- b) Generally, to make and perform contracts of any kind and description, and for the purpose of attaining any of the objects of the corporation, to purchase, sell, operate, repair, own, hold, import, export general merchandise, personal property of every kind, nature and description wheresoever located, both tangible and intangible and including choses in action, either as owner, broker or factor.

d) To engage in any or all lawful activity and to institute, participate in and promote commercial, mercnatile, financial and industrial enterprises, and for the purpose of transacting any or all lawful business.

### ARTICLE IV - POWER

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

#### ARTICLE V - CAPITAL STOCK
