## ARTICLES OF INCORPORATION

OF

## SPORTS INSTALLERS, INC.



- 1. NAME. The name of this corporation is SPORTS INSTALLERS, INC.
- 2. PURPOSE. The purpose for which the corporation is organized is:

The transaction of any and all lawful business for which a corporation may be incorporated under the Florida General Corporation Act; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cametery company or a building and loan association, mutual fire insurance association, co-operative association, fraternal benefit society, state fair or exposition.

- CAPITAL STOCK. The aggregate number of shares of stock which the
  corporation shall have authority to issue is 100 and each share shall be of the par value
  of \$1.00.
- DURATION. The corporation shall have perpetual existence, and its existence shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.
- 5. INITIAL REGISTERED OFFICE AND AGENT. The street address of the initial registered office of the corporation is 30850 Mossy Oak Terrace, Myakka City, Florida 34251, and the name of the initial registered agent of the corporation at that address is Christina Ruetz. - 6. NUMBER OF DIRECTORS. The corporation shall have one director, initially. The number of directors may be increased or diminished from time to time, by by-laws by the stockholders, but shall never be less than one.

Such option shall inure to the benefit of the other stockholders (who desire to accept same) pro rata.
