Article I. - Name

The name of this Corporation is Awit-Young & Associates Inc.

Article II. - Duration

Awit-Young & Associates Inc. shall exist perpetually.

Article III. - Purpose

Awit-Young & Associates Inc. is organized for the purpose of the transaction of any or all lawful business or activities at any of its branches at one or more offices or agencies, both within and without the state of Florida, in any and all other states, territories and colonies of the United States, and in any and all foreign countries, subject to the laws of such state, district, territory, colony or country.

Article IV. - Capital Stock

The amount of paid capital with which the Corporation will commence business is Five Hundred and NO/100 (\$500.00) Dollars.

This Corporation is authorized to issue One Thousand (1000) shares of Common Stock of ONE and NO/100 (\$1.00) Dollars per share which shall be designated Common Shares.

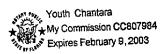
