

ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of the corporation shall be FLORIDA TURF SERVICES, INC.

ARTICLE II-PRINCIPAL OFFICE
