ARTICLE I - NAME

The name of the corporation is:

ARTICLE II - DURATION

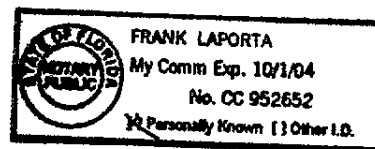
