ARTICLES OF INCORPORATION

OF

BROWARD TRADING COMPANY

In compliance with the requirements of F.S. Chapter 607, the undersigned being a natural person, does hereby act an incorporator in adopting and filing the following articles of incorporation for the purposes of organizing a business corporation in Florida.

ARTICLE I.

The name of the Florida Corporation is Broward Trading Company.

ARTICLE II.

The existence of the corporation shall begin on the date on which these Articles of Incorporation are first filed with the Department of State of Florida and shall be perpetual thereafter. The purpose of this Florida corporation is to engage in the selling, trading, importing and exporting of products and goods to and from Florida.
