We are asking you to waive the late fee for these reasons:

When we first received the Report we sent it back in with \$150 fee but apparently neglected to put in the FEIN Number. The second notice we received was sent in with another \$150. But FEIN was not on that report either, as per Ms Ashton. We received another notice, which at that time I called in to see what was the problem. Ms Ashton notified me that the notice that went out May 9th was late and they did not have our FEIN. The mail situation is horrible. I can personally say that the mail is put in wrong boxes, both at the house and in the boxes in the post office. I stress to my clients to get things in at the proper dates because of the late fees. Because of the extremely large late fee you'll charge, I stress it even more. Because of these circumstances, please consider waiving the fee for us. Affordable Air is just a small company and cannot afford such a large expenditure.
