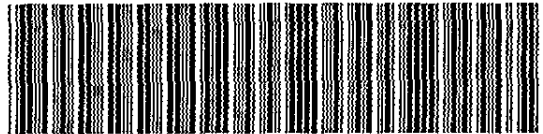

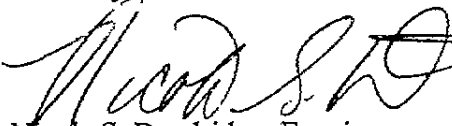

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
BETHEL'S TROPICAL LAWN MAINTENANCE, INC.**

Pursuant to the provisions of Chapter 607.1006 et seq. of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **BETHEL'S TROPICAL LAWN MAINTENANCE, INC.**
2. The following amendment to the Articles of Incorporation were adopted by the Board of Directors of the corporation on November 22, 2002, in the manner prescribed by the Florida business Corporation Act:
