The undersigned incorporator hereby makes, subscribes to, acknowledges and files
These articles of incorporation for the purpose of organizing and incorporating a
corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

And shall hereinafter be referred to as the "corporation".

ARTICLE II

The time and date on which corporate existence of this corporation shall begin at
12:01 o'clock A.M. (Eastern Standard Time) on 01/02, 2001, and this
