



ARTICLES OF INCORPORATION



<u>OF</u>

LOVE PUBLISHING, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

<u>ARTICLE I</u>

The name of the Corporation is Love Publishing, Inc.

The term of existence of the Corporation is perpetual.
