We, the undersigned, do hereby associate ourselves and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

**ARTICLE ONE**

The name of the corporation shall be **RD MEDICAL SUPPLIES INT'L, INC.**

**ARTICLE TWO**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE THREE**

The maximum number of shares of stock which the corporation shall have outstanding at any time, shall be 500 shares of stock which shall be common stock of \$1.00 par value per share. All or any part of the capital stock may be paid for either in lawful monies of the United States of America, or in services, at a true valuation thereof.

**ARTICLE FOUR**

This Corporation shall begin business with a minimum capital of the amount of Five Hundred (\$500.00) dollars.

**ARTICLE FIVE**

This Corporation shall have perpetual existence.

## **ARTICLE SIX**

Initially the principal office of the corporation shall be located at 8810 S.W. 50<sup>th</sup> Terrace, Miami, Miami-Dade County, Florida, 33165; other offices for the transaction of business may be located wherever the Directors may deem necessary or expedient.

## **ARTICLE SEVEN**

The business of the corporation shall be managed by a Board of Directors, who need not be stockholders of the corporation. Originally there will be one director. 
#### **ARTICLE TWELVE**


