# ARTICLES OF INCORPORATION

### ARTICLE I.

NAME: The name of this corporation shall be ALERT-ONE FIRE, INC.

### ARTICLE II.

ADDRESS: The principal office and mailing address of this corporation is 2140 Broadway Avenue, Fort Myers, Florida 33901.

### ARTICLE III.

NATURE OF BUSINESS: This corporation is organized for the purpose of transacting any and all lawful business.

### ARTICLE IV.
