Article I Name

The name of the Corporation is M & R Auto Paint and Body, Inc.

Article II Duration

The Corporation shall commence its existence on $\underline{\text{December 1, 2000}}$ and shall have perpetual existence.

Article II Purpose

The nature of the business to be promoted and carried on, is to engage in any lawful activity for which Corporations may be organized under the General Corporation laws of the State of Florida. The Corporation is organized for the purpose of providing, managing and operating various auto body and mechanical repair facilities. To provide various services relating to the operations of the business as from time to time shall be deemed appropriate.
