ARTICLES OF INCORPORATION

ARTICLE 1 - NAME AND LOCATION OF PRINCIPAL OFFICES

The name of this corporation is: GLOBAL RESOURCES CONSULTANTS, INC., with initial principal offices located at 1701 Kit Lane, Navarre, FL 32566.
