ARTICLE I - NAME AND ADDRESS

The name of this corporation is **CONSOLIDATED HOLDINGS, INC.** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 901 Ponce de Leon Boulevard, Suite 600, Coral Gables, Florida 33134.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is One Thousand (1,000) shares of common stock, all of which are to have a par value of One Cent (\$.01) per share. The power to alter, amend or repeal the Bylaws shall be vested in each of the Board of Directors and the shareholders of the Corporation.


ARTICLE VIII - INDEMNIFICATION
