GENERAL NATURE OF BUSINESS

This corporation may engage in any legal for profit making activity approved in the state of Florida, in any other state within the United States of America, or any foreign country. Businesses in which the corporation may engage include the manufacture, assembly, and sale by both wholesale, and retail of live and artificial floral arrangements, silk plants, trees and gift baskets. CORPORATE EXISTENCE

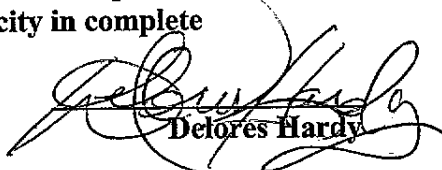
This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these articles, unless dissolved according to law.

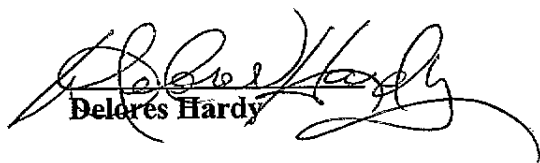
AMENDMENTS

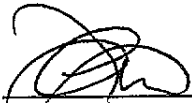

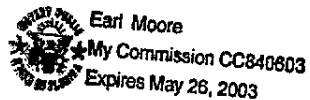
