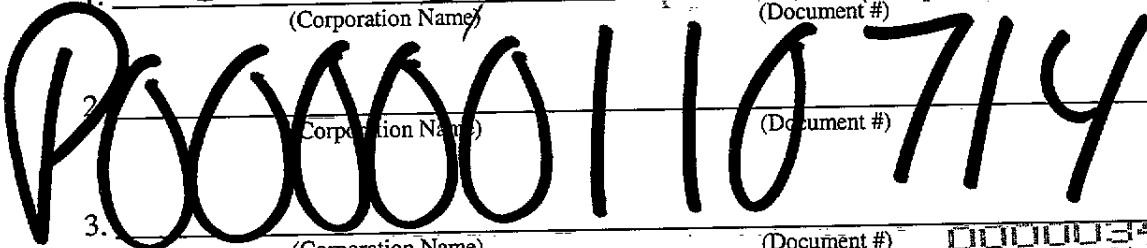

ARTICLE II

GENERAL NATURE OF BUSINESS

This corporation may engage in any legal for profit making activity approved in the state of Florida, in any other state within the United States of America, or any foreign country. Businesses in which the corporation may engage include the preparation of federal, state, and local tax returns; prepare financial statements for businesses and other organizations; prepare books and records; act as electronic filing originator for electronic tax returns; offer internet website consulting; and or, the operation of any other activities or businesses permitted under the laws of the State of Florida.

CORPORATE EXISTENCE

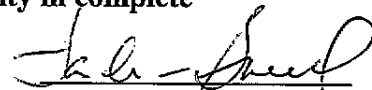
This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these articles, unless dissolved according to law.

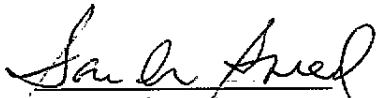
AMENDMENTS
