

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is PAC Leasing, Inc. Its principal office address and business mailing address is 1525 NW 167 Street, Suite 145, Miami, Florida 33169.

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE


ARTICLE VI - INITIAL BOARD OF DIRECTORS




