**ARTICLE I - CORPORATE NAME**

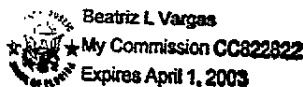


