
To Whom It May Concern:

We, at Prostar Environmental Pest Extermination Inc., would like to thank you for all your help in the past. We sincerely appreciate the extra effort and patience you give to help young entrepreneurs like myself. At this time, we would like to inform you of a serious problem with our Corporation status. It has just recently been brought to my attention that at the present time our Corporation has not been renewed and is about to expire.

We would like to explain our situation and why this happened. On January 29, 2001, our old office requested a Uniform Business Report to change officers, directors, location and to pay the renewal fee of the said Corporation. After receiving the information, the paper work was filled out February 26, 2001 and a money order was purchased for the payment due. At the same time the office was being moved to a new location at 12500 SW 251 Terr., Princeton FL 33032. Juan P. Mursuli resigned and is no longer an officer of the Corporation but is still a shareholder. While in the process of moving the same week and under the responsibility of Mr. Mursuli, some merchandise and boxes were stolen from our old location at 4241 S W 147 Ct. Miami, FL 33185. A police report was filled out and is in the possession of Mr. Mursuli. At the time he claimed to have sent our "UBR" along with a money order he purchased at a local convenience store. However, after our recent discovery, he now states it may have gotten mixed up and lost at the time of the robbery. We were under the impression that Mr. Mursuli had filed the new U B Report until Tuesday Aug. 14, 2001, during our end of year "check list" when called to your office to confirm our Corporation status.

We, at Prostar Environmental, are honest, hard working people. We really apologize for any inconvenience due to our misfortune. Our business is small and this misfortune can really set us back. Therefore, we would like to request a pardon from the fee of \$550.00 for the UBR renewal and to please except our payment for the original fee of \$150.00 for the UBR plus \$8.75 for certificate of status and \$5.00 for Trust Fund Contribution. We will be more careful next time and make these issues our first priority from now on.
