ARTICLES OF INCORPORATION

OF

WILLIAM D. WISE, INC.

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINES

The name of this corporation is WILLIAM D. WISE, INC., and its principal place of business shall be located at 701 N.W. 22<sup>nd</sup> Street, Ocala, FL 34475.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

#### ARTICLE VII - DIRECTORS

Initially, this corporation shall have one (1) Director who shall serve until his successors shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. The number of
