"Our company never received the first notice for its 2001 corporate annual report, and we did not meet the May 1 deadline for filing the annual report."


Your letter dated August 8, 2001 stated that non-receipt of the Uniform Business Report was the only provision that allowed abatement of the \$400 penalty.
