#### ARTICLES OF INCORPORATION OF VALENZUELA & JENSEN CORP.

The undersigned does hereby subscribe to, acknowledge and files the following Afficles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### ARTICLE I - NAME

The name of this corporation is VALENZUELA & JENSEN CORP.
