We, the undersigned incorporators, hereby associate ourselves together and make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

Article One

The name of the corporation shall be: Party Delight Entertainment, Inc.

Article Two

Article Three

This corporation is organized for the following purposes: To operate as agency to provide talent for parties, and other occasions, to plan, organize put on parties and other affairs, to own or lease properties real and personal, in connection therewith, and to do all other things permissible under the laws of the State of Florida, in connection therewith or reasonably necessary to carry out such business operations.

The number of Directors may be altered from time to time by the Bylaws adopted by the stockholders; however, the Corporation shall have no less then one (1) director at any time

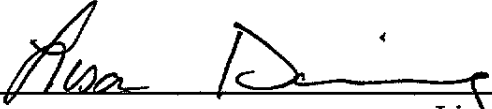
