**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of this Corporation, pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the state of Florida, and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

Name of this Corporation shall be Web Links Corp.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS
