Name

The name of the corporation is ROSS/CRAWFORD GROUP, INC.



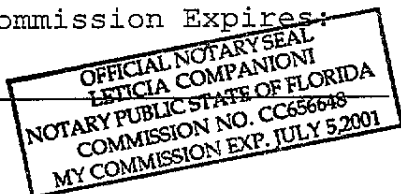


