The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, as follows:

ARTICLE I

The name of the corporation shall be Trails End, Inc. and principal office and registered office are the same at:

ARTICLE II

The purpose of the corporation is to engage in the activity or business of TRUCKING according the laws of the United States and the State of Florida.
