ARTICLE I - NAME

The name of this corporation is **Zachary Anthony Emmanouil, P.A.**

ARTICLE II - DURATION

This corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of practicing law and engaging in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$1.00 par value common stock which shall be designated "Common Shares".

ARTICLE V - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act, as amended from time to time.

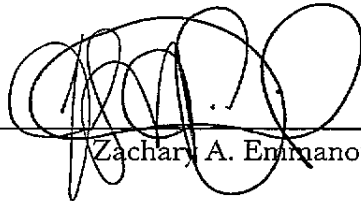
ARTICLE X - INDEMNIFICATION

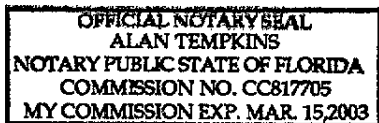

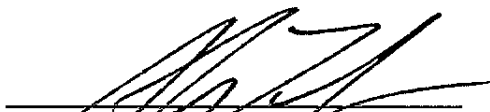
