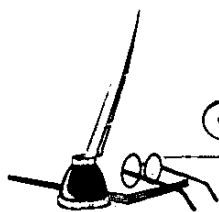

Dear Mr. Scott:

I have talked to you in the past about getting a corporation reinstated. You told me that the Secretary of State would consider reinstatement without the penalty if the forms were never received.


I am the accountant for Edo of Saint Petersburg, Inc., [corporation] a corporation organized under the laws of the State of Florida. I noted when I checked the Division of Corporation's website that the annual fees had not been paid by the corporation since 2001. Ms. Hahn Luu Vuu, the corporation's owner and sole shareholder never received the annual report notices in the year of the dissolution/revocation and was not aware that the corporation had been administratively dissolved until I brought it to her attention.

When I questioned Ms. Vuu about her receiving the annual report notices that the State of Florida mailed to her, she stated she never received the form. Since Ms. Vuu never received the annual report notices, we are requesting an abatement of the reinstatement fees and asking that the corporation be reinstated for the payment of the fees for the periods 2001 through 2006 only in the amount of \$150 for each year or a total of \$900.

The corporation has enclosed its check in the amount of \$900.00 made payable to the Department of State to reinstate the corporation and pay the annual fees for the years stated above.
