ARTICLES OF INCORPORATION OF TDL SITEWORK, INC.

<u> Article I - Name</u>

SELERETARY OF STATE TALLAHASSEE, FLORIDA

The name of this corporation is TDL SITEWORK, INC.

EFFECTIVE DATE

Article II - Duration

11-25-00

This corporation shall have perpetual existence, commencing on NOVEMBER 25, 2000.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Stock

This corporation is authorized to issue 1,000 shares of common stock, with par value of \$ 1.00 which shall be designated "Common Shares".


