
## ARTICLE 1

NAME

The name of this corporation is: JHP Marketing, Inc.

**ARTICLE 2** 

**DURATION** 



The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is 8:00 a.m. on December 1, 2000, provided that these articles are filed on or before December 7, 2000, but if not the date and time of commencement shall be the time of filing of the articles of incorporation by the Department of State of the State of Florida.

#### **ARTICLE 3**
