Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Amendment to the existing Articles of Incorporation being affected hereby is to delete Article I of the Articles of Incorporation and to substitute in its place the following:


ARTICLE I: NAME

The name of the corporation is MedCorp, Inc.

2. This amendment to the Articles of Incorporation was approved on October 28, 2003 by the written consent of all stockholders of this corporation pursuant to Section 607.0704, Florida Statutes, and the written consent of the Board of Directors of this corporation pursuant to Section 60.0821, Florida Statutes.
