ARTICLE I. CORPORATE NAME.

The name of this corporation shall be Cerberus Press, Inc.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business is in Miami-Dade County, Florida, and the mailing address is 7800 Red Road, Suite 123, South Miami, Florida 33143.

ARTICLE III. PURPOSE.
