Article I. Name

The name of the corporation is **Biglane Mortgage Services, Inc.**

Article II. Duration

The term of existence of the corporation is perpetual.

Article III. Commencement of Existence

The corporation shall be deemed to commence on **December 1, 2000.**

Article IV. Principal Office and Mailing Address
