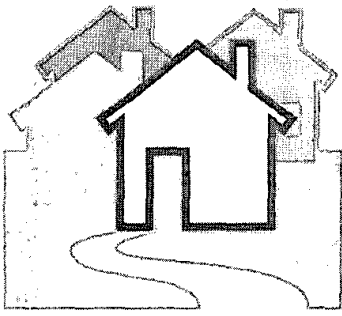

We received a UBR Filing package in the mail today, indicating that we still needed to file the 2003 renewal for Biglane Mortgage Services, Inc.

Please note that we filed this report online on April 8, 2003, and paid using the ECHECK system. I went online to see if our report showed up as filed, and it does not. I also checked with our bank, and that check never cleared our account. I spoke to Mike in the technical support department and he indicated that our report is in your system queue, but was never processed completely because of payment. He also indicated that if our ECHECK did not clear our account, we would need to manually re-file the report and send another check, both of which are enclosed.

We have another corporation (Fee Simple Title Agency, Inc.), and we filed that report online and used the ECHECK system and it went through just fine. We are not sure what happened with the Biglane report. I was told by Mike in technical support that the penalty fee would not be charged to us because he can see where we attempted to file on April 8th.
