The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation is POWERWALL INC.

#### ARTICLE II - NATURE OF BUSINESS

The Corporation shall engage primarily in the manufacture and sales of cementatious coatings including, but not limited to Stucco, Synthetic Coatings and Paints or in any activity or business permitted under the laws of the United States and of the State of Florida.

# ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time is 100 shares of common stock, each having a par value of \$1.00.
