ARTICLE THREE SHARES

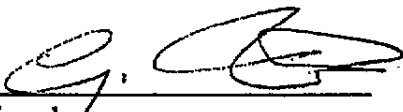

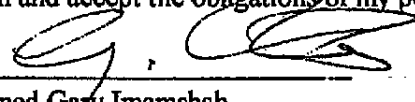

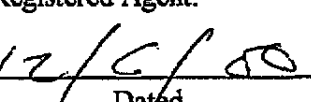
