ARTICLE I. NAME

The name of this corporation shall be J. E. McIntee, P.A.

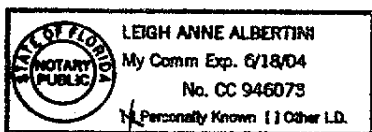
