ARTICLE I. CORPORATE NAME

The name of this corporation is: **FIVE STAR TRUCK STOP, INC.**

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of **providing retail sale of gas, petroleum, food, beverages, alcohol, with accessory related services and products thereto**, and other contractual Related services, along with any and all other business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to Issue and have outstanding at any one time is 10,000 shares of common stock having Par value of at least \$1.00 per share.
