**ARTICLES OF INCORPORATION
OF
MANATEE OF KISSIMMEE, INC.**

THE UNDERSIGNED, acting as sole incorporator of MANATEE OF KISSIMMEE, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**
