ARTICLES OF INCORPORATION OF MEYER COHEN, P.A.

The undersigned, being a natural person, competent to contract and licensed to practice medicine in the State of Florida, acting hereby as incorporator for the purpose of establishing a Professional Service corporation under the provisions and subject to the requirements of the laws of the State of Florida, particularly Chapters 607, Florida Business Corporation Act, and 621, Professional Service Corporation and Limited Liability Company Act, as amended, does hereby adopt and make the following Articles of Incorporation and does hereby certify that:

ARTICLE I NAME

- (c) To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- (d) To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

POWERS

The Corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapters 607 and 621, Florida Statutes, as amended and supplemented.
