AMENDED AND RESTATED ARTICLES OF INCORPORATION OF THE TALLAHARY OF STATE
ESPRESSO ITALIA MARKETING, INC. DATED JANUARY 27,52095 ORIDA

Pursuant to the provisions of Fla. Stat. § 607.1007, the undersigned corporation, ESPRESSO ITALIA MARKETING, INC. ("the Corporation"), originally incorporated on December 7, 2000 under document number P00000112217, and pursuant to the written approval of the Corporation's Shareholders and board of directors, adopts the Amended and Restated Articles of Incorporation set forth below. The Amended and Restated Articles of Incorporation restate and integrate the provisions of the corporation's articles of incorporation, and also contain certain amendments, which were adopted pursuant to the Florida Statutes. There is no discrepancy between the corporation's articles of incorporation and the provisions of the restated articles of incorporation, other than the inclusion of amendments adopted pursuant to Chapter 617 of the Florida Statutes and the omission of matters of historical interest.

# FIRST.

# SECOND.

### THIRD.

The Corporation is formed to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act, as amended from time to time.

# FOURTH.

The Corporation shall be authorized to issue an aggregate number of 500,000,000 shares of common stock, with a par value of \$0.000! per share (the "Common Stock"), and 20,000,000 shares of Preferred in one or more series to have voting powers (full or limited or without voting powers), designations, preferences and relative, participating, optional or other special rights, and qualifications, limitations or restrictions thereof as determined from time to time by the Board of Directors of the Corporation (the "Board of Directors").

# FIFTH.

Pursuant to Section 607.0901(5) of the Florida Business Corporation Act, the Corporation expressly elects not to be governed by the provisions of Section 607.0901 of the Florida Business Corporation Act with respect to any "affiliated transaction" (as defined therein).

Pursuant to Section 607.0902(5) of the Florida Business Corporation Act, the Corporation expressly elects not to be governed by the provisions of Section 607.0902 of the Florida Business Corporation Act with respect to any "control-share acquisition" (as defined therein).

# SEVENTH.

The Board of Directors and the holders of record of 50% or more of the Shares entitled to vote at such meeting are authorized to call a special meeting of the Shareholders of the Corporation.

### EIGHTH.

These duly adopted, Amended and Restated Articles of Incorporation supersede the original articles of incorporation of the Corporation.

# NINTH.

These Amended and Restated Articles of Incorporation shall be effective upon filing with the State of Florida.

These Amended and Restated Articles of Incorporation, in accordance with the provisions of Section 607.1007 of the Florida Business Corporation Act, were duly adopted by the Board of Directors and the Shareholders of the Corporation, with the number of votes cast for these Amended and Restated Articles sufficient for approval.
