ARTICLES OF INCORPORATION

OF

The undersigned, subscriber to these Articles of Incorporation, competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I- NAME

The name of this Corporation shall be: BEL'S FLOWERS & GIFTS, INC.

ARTICLE II- PURPOSE AND POWERS

This Corporation is organized for the purpose of transacting any or all lawful business and shall have all of the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE X-INITIAL CAPITAL

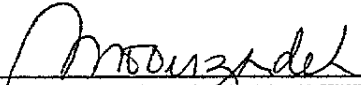
The amount of capital with which this corporation shall begin business is not less than Five Hundred (\$500.00) Dollars.

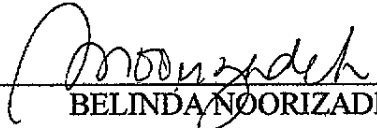

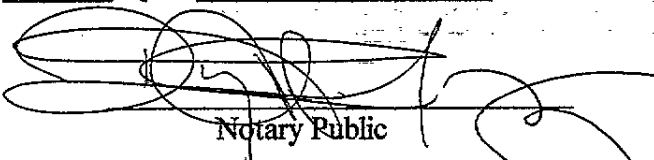
