The undersigned, for the purpose of associating to establish a corporation for the transaction of the business and the promotion and conduct of the objects and purposes hereinafter stated, under the provisions and subject to the requirements of the Laws of the State of Florida, and we do hereby file these Articles of Incorporation in writing and do hereby state as follows, to wit:___

ARTICLE ONE
NAME

The name of the corporation is:

ROYAL PALM PEDIATRICS, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSE

The general nature and purpose of this corporation is to engage in the following activities:

A.) The authority to engage in and transact, within and without the State of Florida or the United States, any and all lawful activities permitted under the laws of the United States and/or of the State of Florida for which

corporations may be incorporated under Chapter 607 of the Florida Statutes;

B.) The Corporation may more particularly engage in the following businesses and/or activities:

1.) To engage in a medical practice, by and through the operation of a Pediatric Clinic Facility, including but not limited to providing medical for children, internal medicine, pediatrics and any and all of the sub-specialties proffered in the pediatric field;

2.) To engage in related Medical Service Industries including but not limited to consulting; sales of medicine, pharmaceuticals, medical equipment, Diagnostic and supplies and information related services.

3.) To engage in the operation and ownership of Medical Diagnostic Centers and/or Facilities, together with any and all activities in connection with or arising therefrom;

4.) To engage in the business of buying and selling Real Estate as Agent or in any licensed capacity as permitted by law and any and all activities related to the Real estate Industry;

5.) To engage in the business of providing any and all types and kinds of services, arising out of or in connection with the medical field, investments,

securities, real estate, including but not limited to the development and construction industries to the extent permitted by law of the applicable jurisdiction.

6.) To engage in the business of import and export and all matter arising from or in connection with said activity;

7.) To engage in the real estate business and as broker, and in any lawful capacity, and generally to take, lease, purchase, or otherwise acquire, and to own, use, hold (including holding for investment), sell, convey, exchange, lease, mortgage, work, clear, improve, develop, divide, and otherwise handle, manage operate, deal in and dispose of real estate, real property, lands, multiple dwelling structures, houses, buildings, and other works and any interest or right therein;

8.) Furthermore, the corporation may take lease, purchase or otherwise acquire, and own, use, hold, sell, convey, exchange, hire, lease, pledge, mortgage, and otherwise handle, and deal in and dispose of, as principal, agent, broker, and in any lawful capacity, such personal property, chattels, rights, easements, privileges, choses in action, notes, bonds, mortgages, and securities as may lawfully be acquired, held, or disposed of, and to acquire, purchase, sell, assign, transfer, dispose of, and in general deal with, as principal, agent, broker, and in any lawful

capacity, mortgages and other interests in real, personal and mixed properties;

9.) And may carry on a general construction, contracting, building, and realty management business, as principal, agent, representative, contractor, subcontractor, and in any other lawful capacity;

10.) And to engage in any and all real estate activities both domestic and foreign and effect the purchase and sale of all kinds of real estate property of whatever nature and wherever situated.

ARTICLE FOUR CAPITAL STOCK

This corporation shall be authorized to issue one kind of stock which shall be deemed to be Common Stock. The total number of authorized shares shall be ten thousand (10,000) shares. Each share representing 1/10,000 of the ownership of the company. The Corporation shall assign a NO PAR VALUE to each and every share of Common Stock.

BY-LAWS


The initial By-laws of this corporation shall be adopted

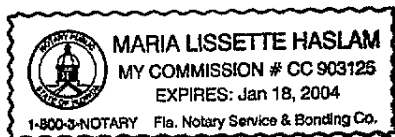



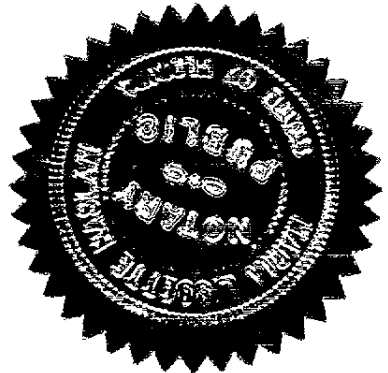
