ARTICLES OF INCORPORATION

OF

CAPITAL MANAGEMENT CONCEPTS, INC.

ARTICLE I

NAME

The name of this corporation shall be CAPITAL MANAGEMENT CONCEPTS, INC., hereinafter referred to as the corporation.

ARTICLE II

DURATION


