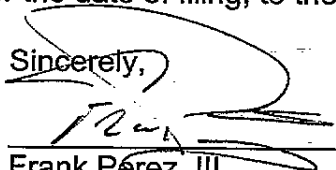

ARTICLE IV

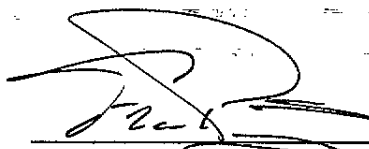

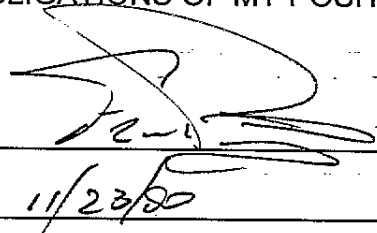
