#### ARTICLES OF INCORPORATION

OF

# TRICIA R. PLANK & ASSOCIATES, P.A.

The Undersigned subscriber to these Articles of Incorporation, a natural person competent and licensed to practice certified public accounting in the State of Florida, acting as incorporator for the purpose of forming a professional service corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

# ARTICLE I NAME

The name of the corporation shall be TRICIA R. PLANK & ASSOCIATES, P.A.

#### ARTICLE II NATURE OF BUSINESS

The principal place of business and mailing address of the corporation is 2080 Poinciana Road, Winter Park, Florida 32792.

# ARTICLE III NATURE OF BUSINESS

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are: (a) to engage in every aspect of the practice of certified public accounting, and all of its fields of specializations as are engaged in by certified public accountants, (b) to engage and render the professional services involved only through its officers, agents and employees who shall be certified public accountants in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation, (c) to invest its funds in real estate, mortgages, stocks bonds and any other type of investments permitted by law, (d) to engage in no other business other than the rendition of the professional services specified herein, and (e) to do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
